Brice Harris (Board of Governors) reasoning that conflicts between District Admin and Bd of Trustees need oversight; Trustees not filling fiduciary responsibilities. Union indicates State Fiscal monitor (Austin) said Peralta is on solid financial ground. Point: there is now a new Chancellor (Carla Walter) and 2-3 new Board members pending.
