New Business	A. Report on Bezemek's recent legal work regarding pensions:	
	The "California Rule" states that once you're vested, pensions can't be changed.	
	But the current language is "ought to" rather than "shall."	
	Bezemek wrote an amicus brief and asked if PRO can sign on. If the CA Supreme	
	Court throws out the CA Rule, it could threaten current pensions and benefits. If	
	Court affirms CA Rule, that would be the end of this challenge. The issue wouldn't	
	go to the US Supreme Court because the provision is in the CA constitution.	
	B. Use of database for elections/Board of Trustee phone banking and canvassing	
	Can the PRO database be used for election work? PFT COPE Chair, Jeff Sanceri, is	
	setting up phone banks and canvassing for members who live in Trustee Areas 3	
	and 5. In the past PRO has not endorsed candidates for the Peralta Board.	
	CFT can sort and give information back to PRO as to members who live in these	
	areas.
