From the President...

Greetings retirees. I hope this newsletter finds you all in good health and enjoying your retirement years. Heaven knows we deserve it.

This is the inaugural newsletter for our new group, the Peralta Retirees Organization – PRO.

For the past few months a number of us retirees, spurred by what we perceived to be threats to our guaranteed lifetime health benefits, have worked to form a core group to which we hope we will add all Peralta retirees and create a formidable body to protect us, to help us have good times with each other, and to continue to serve the Peralta community and the students to whom most of us have devoted our careers.

HISTORY

Here's a short history of PRO, which only has a short history:

A group of 12-20 used to meet periodically at Round Table Pizza in Lafayette strictly for social purposes. When we heard that Peralta was considering some modification in our guaranteed lifetime health benefits, and we were informed that none of the unions that represent active employees, represents retirees, we recognized that since no one else represents us, we would have to represent ourselves.

We invited Mike Baldinelli, then Peralta's risk manager (he's since been fired) to address the Lafayette group about our health care status. He actually met with us twice – the second time at his own request – and had some sobering news. Though the district cannot modify our benefits while it is solvent, if it ever goes bankrupt, our benefits will be in jeopardy.

At that point we decided to form an organization. We sent out a letter to about 450 retirees asking them to respond with contact information and to attend an organizational meeting

Without a reservation, you won't be able to join us for lunch. You do not have to attend the luncheon to come to the business meeting which will start at 1:30 PM.

on June 23. Over 220 responded, and more than 100 showed up at the meeting – extremely encouraging results. Many who responded to establishing a retirees group said, "It's about time!"

A group from that meeting volunteered to formally structure PRO, and for the past few weeks, it's been happening. A constitution and bylaws have been written (We tried to keep them as simple as possible.), a PRO website has been established (www.peraltaretirees.org), and interim officers have been chosen: *President* – Jerry Herman – Faculty, Laney and Vista – 41 years (and counting) *Vice-President* – Remo Arancio – Faculty and Manager

– Laney, Merritt, Vista, District – 34 years Secretary – Juanita Peterson – Faculty – CoA, Laney and Merritt – 29 years

Treasurer – Shirley Timm – Faculty and Manager – Laney, District – 29 years *Webmaster & Newsletter Editor* – Bruce Jacobs – Faculty

– Laney and Merritt – 32 years

A formal election including all PRO members will be initiated at a meeting scheduled for Nov. 10.

In addition to organizing PRO, the volunteer group has been working to help the District out in the debacle of the transfer of members from Blue Cross to CoreSource/Interplan. We've fielded phone calls and e-mails, sent out correspondence, and analyzed the CoreSource/Interplan plan to make certain it is equivalent to Blue Cross benefits. Our work in this transition period made the necessity of organizing PRO dramatically evident.

STATEMENT OF PURPOSE

We have developed a PRO statement of purpose that we hope will guide us in what we want to do as a group of unified retirees:

The objectives and purposes of this independent, non-profit organization called The Peralta Retirees Organization (PRO) shall be:

- to provide assistance to and representation for the members in matters relating to retirement;
- to generate and distribute information concerning retirement issues;
- to initiate, sponsor and encourage activities that will improve the general welfare of the members;
- to aid the greater Peralta Community College District community through volunteer service;
- to accept, maintain and expend funds by way of dues, gifts, grants, or from other sources to promote and advance these purposes.

We have also been looking into the activities of other

college retirement organizations to see what we might add to better serve Peralta retirees.

DUES PAYING MEMBERSHIP

We have established dues as \$20 per year. PRO will serve all Peralta retirees regardless of how many pay dues, but only dues paying members will be allowed to vote in PRO's elections and receive the PRO newsletter. Let's face it, these may not be compelling reasons for retirees to pony up \$20 every year. The surpassingly more important reason is that if we are to have a viable organization, we need funds to pay for its services. We hope that those who want to see PRO succeed in its purposes and avail themselves of PRO's services will be willing to pay the dues to support it. The dues will be used to fund the newsletter and website, to pay for social events, and to defray the costs of any legal services we may need, and to establish a PRO scholarship if we have enough to do so.

At \$20 per year we believe that we have made the dues affordable to everyone, but at that low amount we will need lots of dues paying members to allow PRO to serve retirees adequately. We're counting on nearly all of the close to 500 retirees to reach for their checkbooks and write that \$20 check to Peralta Retire Organization or PRO. If you are also paying for the Nov. 10 luncheon (\$8.75), you can make the amount \$28.75 which will cover dues and the luncheon. Please mail the check to:

An Overview Of PCCD Health Benefits Plans For Retirees

By the time you read this article, all Peralta retirees formerly enrolled in Blue Cross and currently not enrolled in Kaiser should have received their new

CoreSource/Medco ID cards. If the coverage is for both you (retiree) and your spouse, you will have received two identical ID cards. Both cards will show the retiree's name as "Participant". Your spouse will not be named on either ID card. However, your spouse can use either card with your name on it since the spouse is identified by her/his name in the CoreSource/Medco data files under your social security number (ID Number).

The gray space on the ID card following "ID Number" (retiree's social security number) is blank because of State and Federal privacy laws. However, if you choose to disclose your social security number, you may print it in the gray area. If you print your social security number on your ID cards, do not put the numeral "1" in front of your SSN. If you do not print your social security number on the ID cards, be prepared to provide your SSN when obtaining medical services. Please note, you do not have to call the precertification number on the ID card to activate your card. Your card is ready to use when you receive it. Your medical services provider is the one who, usually, will call the precertification number when it is necessary to obtain authorization for certain services.

A summary of the CoreSource/Interplan Retiree Preferred Provider Plan is provided on the web site: <u>www.mybenergy.com</u>. For site access enter USER ID: retirees PASSWORD:benefits.

For your information, one item in the CoreSource Benefits Summary shown on the web site has yet to be corrected though the correction has been verbally acknowledged by CoreSource. Under "Routine adult physicals" the "\$25 copay per visit" should be changed to read "Plan pays 100%." Also, under this category, mammograms are not limited to the \$250 per calendar year cap, but this procedure does require precertification.

Some other benefits that have been verbally verified by CoreSource but are not listed in the Benefits Summary are as follows:

Ambulance service, when medically necessary: Plan pays 100%

Home health care: Plan pays for 100 days per calendar year

Skilled nursing facility: Plan pays for 100 days per confinement

These services, as well, generally require precertification

and the authorization is usually obtained by the medical services provider. If you have any questions concerning the preceding items, including routine adult physicals, or any benefit in general, call CoreSource Claims Center Customer Service at 1-866-280-4120.

Most retirees enrolled in CoreSource reside in the 12 states (including California) for which Interplan has a direct PPO network. The back of the ID card for these retirees will provide contact information for Interplan. For retirees in all other states for which Interplan does not have a direct network of medical providers, the ID card identifies the primary network of providers as "PHCS" (Private Health Care System) with appropriate customer service numbers, web sites and provider billing data on the back of the ID card.

All retirees continuing with Kaiser will not be affected by the recent change undergone by former Blue Cross participants. Kaiser health benefits and access have remained unchanged. For summaries of the Kaiser health plans go to web site: <u>www.mybenergy.com</u> and enter USER ID: retirees PASSWORD: benefits.

The Kaiser HMO Plan, for retirees who do not have Medicare or who have not assigned their Medicare benefits to Kaiser, does not provide dental or vision benefits. The Kaiser Senior Advantage Plan, for retirees who have assigned their Medicare benefits to Kaiser, does provide dental and vision benefits in addition to all the benefits of the HMO Plan. In both Kaiser plans you will be reimbursed \$4 of your \$5 copay for each drug prescription by sending fully itemized receipts to Karen Anderson at the Peralta District Office.

If you are a retiree age 65 or older you can apply for Medicare. STRS will pay the premiums for Part A (if you do not qualify under your spouse's coverage) and the Peralta District will reimburse you for the premiums you pay for Part B. Whether you are enrolled in Kaiser or CoreSource, it would lower the Peralta District's medical insurance costs if you enrolled in Medicare and either assigned your Medicare benefits to Kaiser's Senior Advantage Plan , if you are a Kaiser member, or used Medicare as your primary coverage and CoreSource as your secondary coverage, if you are a CoreSource member. Contact Karen Anderson at the District Office to get this process started.

One last bit of news. I have been told by CoreSource that Benefits Plan booklets are being prepared for CoreSource participants. There will be a Plan version for retirees and a Plan version for active employees. After the health plans have been finalized and all elements in the
