From the President...

Greetings PRO Members:

The PRO Board recently elected me President. As many of you know, Jerry Herman decided to step down as the organization's president after ten years of dedicated service. However, I will be counting on Jerry's mentorship to help me in my new role, which will be nothing new as Jerry has been my mentor since I first walked onto the Laney College Campus in the mid- 1970's.

I was an eager but completely untrained applicant for an English Department tutoring position in their innovative Right- to- Read Program designed to help returning Viet Nam Veterans and others in need of remedial reading instruction. Within the sparsely equipped classrooms of the B Quad at Laney College, I discovered my passion for teaching basic skills students. I took the advice of Jerry, Carmen Rezendes and Trudy Fator and pursued a master's degree, specializing in reading instruction.

After more than ten years of working part-time, I was finally permanently hired in 1999. Jerry again emerged as my mentor, this time as a member of my tenure review committee as well as my department chair. As always, Jerry gave generously of his time and talents.

I followed in Jerry's footsteps and became a cochair of our department in 2002. Right around that time, I also was urged by Bruce Jacobs to serve as Laney PFT Campus Representative. the PFT President will help me as I take on the new responsibility of PRO President.

My priority for PRO is similar to that of all the people who sit on the Board: to be vigilant about our retiree benefits. To that end, I will continue to serve on the District Benefits Committee along with Alex Pappas and Tom Branca. I have been on the committee for eight years and have been a part of both discussions and negotiations regarding retiree health benefits. I have worked with Bruce Jacobs and Diana Lara to review the most recent Summary Plan Descriptions -- the documents that detail our medical benefits. When I was PFT President I worked with Bruce to start a PRO/PFT workshop on understanding Medicare. This annual workshop continues today, thanks to Bruce's continued willingness to share his knowledge with the Peralta community. I have also been in the most recent conversations PRO and PFT have had regarding Medicare D and together with Tom Branca and Bruce, I have been playing an active role in trying to help secure a new insurance broker for the district.

My Trip to the Land of Jesse Helms

From time to time the Peralta Retiree publishes first person accounts written by retirees about experiences from their lives after they have retired. The following is an account of a trip out-of-state by a retiree who wanted to participate in the recent mid-term national elections. — Ed.

Note: The following piece is blatantly partisan. You are advised!

When I retired in June, many people asked me what I planned to do with "all that time" on my hands. I usually replied that I intended to do whatever I felt like on any given day.

But as the November elections approached, the campaign trail was calling me to get involved. I decided to participate in Get Out the Vote (GOTV) activities outside of California.

My first choice was Kentucky. It would be satisfying to work for any person running for the U.S. Senate against Mitch McConnell. You may recall in 2010 McConnell said that "the Republicans' single highest priority should be to make President Obama a one-term president." It would be fun to "retire" Mitch McConnell

But as I looked at the polls showing McConnell's opponent, Alison Grimes, lagging far behind, I decided to go elsewhere.

In North Carolina, incumbent U.S. Senator Kay Hagan was ahead of Thom Tillis, her opponent, by a few points. As North Carolina State Speaker, Tillis had slashed education funding, opposed the minimum wage, ended the state's Earned Income Tax Credit, supported turning Medicare into a voucher program, and was a primary architect of voter suppression laws. It would be a worthy endeavor to deny a seat in the U.S. Senate to this "son" of Jesse Helms (the staunchly segregationist North Carolina Senator from 1973-2003).

I called my sister, Kate, in Philadelphia, and asked, "Want to spend some time in North Carolina?" She said, "Sure!" so off we went to connect with the

Hagan campaign for GOTV.

When the GOP took over the North Carolina legislature and executive branch in 2012, Speaker Tillis and his Republican colleagues passed laws that reduced early voting days, eliminated same-day registration, shut down polling places on college campuses and in neighborhoods with a large number of African-American voters, required that voters go only to their assigned precinct (i.e. no provisional ballots allowed), and constructed other barriers for people who were not likely to vote Republican.

In addition, from an article by Greg Palast I learned that North Carolina implemented a "Crosscheck" system to purge people from the voter rolls. The system identifies people who may have voted in more than one state, using only a cross-match of first and last names. If John Johnson voted in Georgia and in North Carolina, then he must be a "double voter!" This system fraudulently disenfranchises legitimate voters, particularly voters of color.

From Palast: "The program's method of identifying and purging voters especially threatens the registrations of African-American, Asian-American and Latinos who are 67 percent more likely than white voters to share America's most common names: Jackson, Washington, Lee, Rodriguez and so on."

Unfortunately, Tillis won by 48,000 votes. In postelection analysis, Palast concluded that the Crosscheck purges could have accounted for Tillis' victory. Crosscheck identified 589,393 North Carolinians as possible "double voters;" state officials subsequently reduced the number to 190,000. North Carolina won't release the names on the list for independent inquiry because all these voters are "subjects of criminal investigation" and thus North Carolina contends the information is confidential.

The results of the election were deeply disappointing. But Kate and I met some incredible people in the nine days we spent in North Carolina.

- Sara and Hugh, retirees and activists who opened their home in Raleigh as a neighborhood Hagan campaign hub. Sara was an English teacher at St. Augustine's, an historically black college in Raleigh, and Hugh worked assisting countries to set up democratic elections. Sara and Hugh are also plaintiffs in a lawsuit challenging the new North Carolina voter regulations.
- Journalists from Myanmar (Burma) who arrived at campaign headquarters in a mini-bus to pick up tickets for a Bill Clinton rally happening the following day. They were travelling to North Carolina and Louisiana to learn about the election process. Myanmar is having parliamentary elections in 2015.
- Mr. Garrett and his son (wearing an A's cap) who came to get tickets. He shared with us his strategies to get his large extended family to vote.
- Ms. Jackson, an elderly woman using a walker, whom we met while knocking on doors in a blue collar neighborhood. Her final words to us: "We can't have Tillis"
- Michael, a veteran who was determined to canvass precincts although it was apparent walking was painful. He received help from Hagan with the VA because he needs a hip replacement.
- Ms. Slade, age 93. She said her leg "didn't work so well now." People from her church went to vote the previous week, but she couldn't go and she didn't want to impose. We arranged for a driver to get Ms. Slade to the polls.
- Frances, age 83, who told us she had to vote at three different machines before her vote for Hagan was accurately recorded.
- Three students from St. Augustine's University who were recruited while on a march to the polling place from the university. Although initially hesitant to canvass, they returned energized and walked a second precinct.

- Robert, a minister whom I accompanied to walk precincts on election day. Robert is legally blind. As he spoke to voters, they listened.
- The candidate, Kay Hagan. When Robert and I stopped for lunch at Bojangles, I went to use the restroom. As I exited, Kay Hagan was waiting alone in line. I was surprised to run into her serendipitously and blurted out, "Hi, I'm Helene and I'm from California and Robert and I are walking for you. Can I introduce you to him?" Even though it was election day, I was struck by how calm, centered, and responsive she seemed.

As I left North Carolina, I felt bad for the people I met. They woke up on November 5 to learn that their fellow North Carolinians had selected Thom Tillis who had done all he could to block their vote.

What's next? I feel compelled to work on efforts opposing voter suppression. What is more fundamental in a democracy than the right to vote?



Health Benefits Update

Medicare D Reimbursement

The PFT and the District have been negotiating about the District reimbursing retirees who have to pay a Medicare D premium (known as Part D Income-Related Monthly Adjustment Amount or IRMAA) as a result of enrolling in Kaiser Senior Advantage. A tentative agreement between the PFT and the District will require the District to reimburse the IRMAA cost for retirees who retired **after** May 1, 2013. Because the PFT cannot negotiate for retirees (as they are not members of the bargaining unit) the agreement does not cover retirees who retired prior to the current contract between the union and the District.

PRO Vice-President Bruce Jacobs attended the negotiations as part of the PFT team in order to provide Medicare expertise. PRO will be taking the next step in obtaining Part D reimbursement for everyone having to pay the IRMAA, *i.e.*, people who retired **prior** to May 1, 2013, by formally requesting that the District extend the agreement to all retirees. If we are able to reach an agreement with the District we will send an email with the details as well as report on it in the next newsletter.

New Broker Delay

PSW Benefit Resources, the District's broker for employee benefits, went out of business on December 31, 2014. The District initiated a process for finding a replacement for PSW with the goal of having a new broker in place by January 1, 2015. The broker decision is important to retirees because understaffing in the District Benefits Office often means that we rely on staff at the broker's office to resolve problems with Blue Cross or Kaiser

The replacement process involved a screening committee that included representatives from various District constituencies including PRO (represented by PRO Board member Tom Branca) that reviewed the applicants. At the end of the process the committee made a recommendation. However, some of the committee members (including Tom) were unhappy with the process and with the outcome. PRO, working with the PFT and Local 39, appealed to the Board of Trustees and the Chancellor. As a result they decided

To The Editor:

Protect Our Prescriptions By Ordering When Needed

Caremark oh-so-kindly enrolls us in automatic refills for our prescriptions, but they tend to refill sooner than actually needed. Over time that can build up into quite a surplus — all of which Peralta has to pay for at Big Pharma prices if generics are not available.

I have refused to enroll in automatic refills and order when I'm a few weeks away from running out. It's no big deal, it's easy, and reducing that surplus — which only goes to waste when we expire — saves a few bucks and reduces the pressure on benefit costs.

I have not been able to get Caremark to do automatic renewal without automatic filling of the order, even if it's not needed. Case in point: I have a three-month supply of one item, but the prescription is expiring. Despite my wishes, Caremark is getting the authorization from the doctor to send me another three months' worth, and will keep it coming unless I change the default auto refill.

The Peralta Benefits office didn't seem concerned about this when I asked awhile back, so it is clear that this is something we have to do ourselves.
